(i) executes and records in the records of Routt County, Colorado, a quit claim deed conveying unto the then fee owner of the real property which is burdened by said easement, or which is burdened by the part of said easement which is to be so vacated and released, all of its right, title and interest in and to said easement, or part thereof, or (ii) executes and records in the records of Routt County, Colorado, a document stating that said easement, or that part thereof which is to be vacated and released, is so vacated and released.
