and to him, heirs, the said Tract ... above described; To HAVE AND TO HOLD the same, together with all the rights, privileges, immunities and appurtenances, of whatever nature, therewith belonging, unto the said

William E. Knight

and to him, heirs and assigns, forever; subject to any vested and accrued water rights for mining, agricultural, manufacturing or other purposes, and rights to ditch and reservoirs and in connection with such water rights as may be recognized and acknowledged by the local authorities, laws and decisions of Courts, and also subject to the right of the proprietor of a vein or lode to extract and remove his ore therefrom, should the same be found to penetrate or intersect the premises hereby granted, as provided by law. And there is reserved from the lands hereby granted, a right of way thereon for public or private purposes by the authority of the United States.

IN TESTIMONY WHEREOF, I, Benjamin Harrison, PRESIDENT OF THE UNITED STATES OF AMERICA,

have caused these letters to be made patent and the seal of the General Land Office to be hereunto affixed.
